Pick up & Drop off - We are entering a property at your request; therefore we cannot accept responsibility for any damage. We must be able to drive directly to the shed. Path to area where shed is to be set must be **clear of all wires, trees, overhangs of 14' and lower**. Please note that our truck and trailer are a total of 50 ft. long, please allow for this size vehicle when deciding pick up and placement of your building. Init _____

Other charges - There will also be additional charges for any fence removal, site improvement, pushing sheds, trimming trees, tow truck fee etc. Init _____

Shed Moving Machine (Mule) – If not already expressly factored into the move cost, if we are unable to drive directly to the prepared site, and our shed moving machine must be utilized a charge of 75.00 will be assessed. Init _____

Moving - It is understood by the customer that the shed moving, can cause loss of shingles, trim, screens etc. Init _____

Pictures – Ample pictures are required prior to the pricing of the move to show the type of shed as well as the path of the shed move (showing both pickup and drop-off locations if applicable). Init _____

Permits – Customer is responsible for all building permits and **proper** site preparation. Init _____

Shed base - It is recommended that the shed be place on a bed of crushed ¾” stone, one foot larger than the shed on all sides. If the stone base is provided by the customer the base must be level, if base is not completed properly, the cost of properly completing the installation is defined on stone pricing sheet.

Wood Borders: If a wood border used as a perimeter for the stone base, we ask you leave the end open that our trailer has to back on too. We can't be responsible for damage occurring due to backing over wood border.

Blocks: Blocks are not recommended, however, if shed is to be placed on block provided by us or customer. (See stone pricing sheet)
